## **RESEARCH AND SCHOLARLY ACTIVITIES**

### **a) Research interests are:**

Industrial Planning in Developing Countries - particularly scale/technology choice and industrial economic performance (with specialisation in the agro-industrial and small-scale sub-sectors).

Project Planning and Appraisal Methods in less developed countries (relating especially to project rehabilitation, monitoring and evaluation, and risk / uncertainty).

Economic Development Planning and Policy Issues in less developed countries. Development and Project Planning in Ghana and Uganda.

### **b) Research Activities**

My research and related activities have had several foci.

First, I have a long-standing interest in the economic development of sub-Saharan African countries, and particularly of Ghana and Uganda. The major book written with Mozammel Huq is one significant output from this, and the interest continues.

Second, I have developed an interest in the analysis of Aid and Development and several recent papers have resulted from this. Again this interest continues, demonstrating – inter alia – the interaction between teaching at a postgraduate level and the development of research leading to publications.

Third, relating to my interest in Industrial Development, there have been several publications in this area including a co-edited book and several articles / chapters relating to small-scale industrial development and to environmental aspects of industrial development.

Fourth is an interest in project analysis, and the article co-written with Professor Ian Livingstone demonstrates this, as well as the synergy between postgraduate teaching and academic writing. The preparation of a major case study on a small-scale milk processing plant in Western Kenya for the Kenya Institute of Administration is another example of this interest.

Fifth is work on the nature of scale economies in the cane sugar industry, started before leaving the University of Strathclyde and two key publications from the mid-1980s with Robin Alpine still stimulate significant interest (and citation). The interest in the cane sugar industry in developing countries was also related to the development of a set of training materials for the Open University in the mid-1980s.

Sixth was a programme of work (much of it jointly with Michael Yaffey at Bradford University) relating to “project rehabilitation” in developing countries from which a book and a number of other papers resulted.

Seventh, the academic link with three Ghanaian universities which ran from 1991 to 2011 involved the supervision of five doctoral theses with the successful candidates later developing high profile careers.

The dissertation was not formally submitted until 1968 and the degree was awarded in 1969. An article based on the main findings of the survey was published in the **East African Economic Review** in June 1968.

2) At the University of Glasgow I made some progress on the same line of interest, but my major output at this time was a paper on the "Economic Aspects of the Asian Expulsion from Uganda" which was published as a chapter of Michael Twaddle's book in 1975 which considerably developed a mid-1971 article on the Ugandan Economy.

3) From October 1973 to September 1975 I worked full-time on a research project funded by the ESCOR of the Overseas Development Administration on "Social Security in Developing Countries". Link to earlier research provided by household consumption/ urbanisation aspects of housing/urban development research in Uganda. Overseas travel, principally for data collection, took place in November/ December 1973 to Geneva (ILO), Addis Ababa (UNECA), Nairobi - Kenya, and Lusaka - Zambia. In addition to working papers and reports, publications in the **International Journal of Social Economics**, **Journal of Modern African Studies** and **African Affairs** (review) resulted from this research.

4) In September 1978 I joined the David Livingstone Institute, University of Strathclyde, where I was initially a member of a research team consisting of 7 economists and technologists working on the "Business Behaviour Research Project" (related to the economic analysis of operating factories and of the choice of production techniques in specific industries in developing countries). I was jointly responsible for data collection in the cane sugar industry with fieldwork visits to factories and other relevant institutions in Ghana, Cote d'Ivoire, Burkina Faso (then Upper Volta), Kenya, Ethiopia, India, Bangladesh, Thailand, Malaysia, and Pakistan during October 1978 - January 1979. Data analysis followed the return to Strathclyde. This research was financed by the ESCOR of the Overseas Development Administration over the period July 1978 to June 1980.

The major output from the "sugar industry" element of the research was a discussion paper followed by two major journal articles (jointly written with Robin Alpine of Strathclyde's Economics Department) concerning the analysis of scale economies in the **Oxford Bulletin of Economics and Statistics** and in **Engineering Costs and Production Economics**. In addition a conference paper, and two brief articles in the Bank of Sierra Leone's **Economic Review** and the **Nigerian Journal of Co-operative Development** were direct outcomes of the research.

During secondment to the Centre for Development Studies, University of Cape Coast, Ghana (July 1982 to June 1984) I prepared two research papers. One concerned the investment appraisal procedures of the National Investment Bank with particular attention to the issue of technology selection. The other involved a careful ex-post evaluation of a sugar estate and factory which had reached a semi-derelict state by the early 1980s, with especial attention to the extent to which technology choice might

have affected the course of events leading to the decline and failure of the project (despite a World Bank-funded rehabilitation in the 1970s). The latter paper particularly involved assembly of “plant-level” data, but both were based on data supplied by the Ghanaian staff of the respective organisations following official approval of the research.

## **TEACHING AND TRAINING ACTIVITIES**

Since taking early retirement from the University of Bradford in mid-2002 I have undertaken part-time teaching activity, first with the University of Bradford, and then with the Universities of Manchester, Strathclyde and Glasgow.

For the **University of Bradford** see below.

For the **University of Manchester** I supervised Masters students’ dissertation preparation over the years 2003, 2004 and 2009 to 2011, and contributed a one-semester Masters course in Economic Development for three years in 2008 to 2010 for the Institute for Development Policy Management (now the Global Development Institute).

For the **University of Strathclyde** I supervised Honours year dissertation preparation, and Masters dissertation preparation, for the Department of Economics from 2005 to 2015 – and also took Honours year seminars / tutorials in Current Economic Issues from 2007-2008 to 2011-2012, as well as tutorials for Masters courses in Microeconomics in 2013-2014.

For the **University of Glasgow** I have been either individually or jointly responsible for the delivery (including assessment) of courses in Aid and Development (2011-2012 to 2014-2015 and 2016-2017 to 2021-2024, with a contribution in 2015-2016), Project Planning, Appraisal and Implementation (2008-2009 and 2009-2010), Development Policy (2009-2010, 2017-2018 and contributions in 2013-2014, 2014-2015 and 2016-2017); Financial Institutions and Markets in Developing Countries (2018-2022 – jointly with Alberto Paloni). In addition I have supervised Masters dissertation preparation for the Centre for Development Studies / Adam Smith Business School from 2010 to 2024.

### **Bradford Centre for International Development, University of Bradford 1985 to 2008:**

1) Major teaching in the **Masters Programme** in Development Planning and Development Policy core courses during the period from 1989-90 to 2007-2008 as well as contributions to other courses within the Masters programme and supervision and marking of extended essays / dissertations. In this period I was also responsible for introducing a pre-Masters **Diploma in Development Economics**.

2) For much of this period I was responsible for the teaching of an **Undergraduate** course in Development Economics.

3) From the early 1990s I had an increasing role in **Doctoral Research** supervision, particularly associated with the **Ghana Development Studies Link Programme**.

4) In the **Professional Development and Training Programme** I provided a major teaching input to the Agro-Industrial Projects Short Course from 1985 to 1995 as well as to other short courses in this programme. I directed a **Chevening Programme** three month course on public service provision in the early 2000s.

5) I provided a significant input into the **Overseas Teaching / Training Programme** from 1987 to 2004. In 1992, 1993 and 1994 I contributed about half of the teaching and assessment for the Project Analysis core course in the Makerere University (Uganda) Economics Department's MA in Economic Policy and Planning with University of Bradford colleagues. In 1997 I prepared training materials relating to 'project rehabilitation' jointly with Michael Yaffey (University of Bradford) – this activity included a ten-day data collection visit to Ghana. From 1987 until 1991 I undertook the preparation of a comprehensive teaching case study (a small-scale UHT milk processing plant – involving a project visit for data collection) for the Kenya Institute of Administration funded by the British Council. From 1993 until 1999 I co-directed a two-week short course on the Planning and Management of Development Projects at the Uganda Management Institute funded by the British Council, and undertook an evaluation of UMI/DPPC training, and a training needs assessment for ODA/British Council in May and December 1996. In late 2003-early 2004 I designed, prepared training materials and delivered a one-week course on policy formulation for the Albanian Department for Policies Development and Coordination, Council of Ministers administered by the UNDP with funding from the Government of the Netherlands – this activity involved an initial planning visit of one week, the preparation of training materials (handouts and PowerPoint presentations), a one-week delivery of the course to Albanian trainers, and a one-week visit during which the course was delivered to senior civil servants in the Albanian language.

#### **Previously:**

1) I was a Lecturer in the Department of Economics at **Makerere University College, University of East Africa** (which became Makerere University, Kampala in 1970) from August 1967 to December 1971. My main teaching responsibility was the first year undergraduate courses in the Principles of Economics and The East African Economy. I was also responsible for the second year undergraduate course in Economic Development and Planning in from 1968-69.

2) I was a Lecturer in the Department of International Economic Studies, **University of Glasgow** in 1971-72, 1972- 73 and 1977-78 during which time I gave lectures and seminars for the Diploma in Development Policy and the M.Phil.(Economic Development) relating to the Economics of Development in Industrialisation and Technological Change.

3) In 1979 I undertook a two-week training consultancy in the **State Investment Bank, Ankara**, Turkey relating to the analysis of risk and uncertainty in project analysis – this assignment was organised by the David Livingstone Institute and was funded by the OECD Development Centre.



3) In the David Livingstone Institute, **University of Strathclyde** in April-June 1981 and October-November 1984 I was a team member for 12-week training courses relating to Technology and Development (with particular reference to the choice of industrial technology). Contributions included lectures, seminars, and the supervision of assignments and factory visits. In addition assisted with supervision of postgraduate research students in the Institute.

4) In the period January-March 1981 I was an Inter-University Council Visiting Lecturer in the Department of Economics, Fourah Bay College, **University of Sierra Leone**. The purpose of this assignment was to set-up and run courses of lectures in Macro-Economic Theory and in Micro-Economic Theory for Honours Degree students in the 1980-81 academic year (in collaboration with a second IUC visitor for the second half of the period).

5) In August 1981 I visited the Department of Agricultural Economics, **University of Nigeria, Nsukka** for the British Council Higher Education Division to assist for three weeks in a Workshop on Project Appraisal and Planning Techniques. This assignment was organised by the David Livingstone Institute and was undertaken jointly with Dr Mozammel Huq. In July 1981 visited the Centre for Development Studies, **University of Cape Coast, Ghana** to contribute to the first week of a two-week workshop on Choice of Technology and the Evaluation of Development Projects – this activity was within a David Livingstone Institute project funded by the Ghana Government and the European Community.

6) From July 1982 to June 1984 was one of a team of three seconded from the David Livingstone Institute to the Centre for Development Studies, **University of Cape Coast, Ghana** for a joint training and research project on the choice of appropriate technology. During this period I gave lectures in five training courses of 5-6 weeks, which provided the basis for four chapters of a manual on the choice of appropriate technology, and also prepared two discussion papers on the Komenda Sugar Factory and Estate and one the treatment of technology choice in the loan procedures of the National Investment Bank. This secondment was jointly funded by the Ghana Government and the European Community.

Since 1985 I have developed a range of skills relating to micro-computing which have central to both research work and in lecturing / training material preparation. These skills, particularly involving use of word-processing, spreadsheet and presentation software as well as micro-computer operating systems and in the secure storage of data and document files. From the start of the Covid-19 pandemic in March 2020 I developed a range of skills associated with online delivery of teaching and supervision, particularly based on Zoom software.
